Dear Fellow Shooters:

GREAT NEWS REGARDING OUR R . V . LINE IMPROVEMENTS!

Our construction projects are nearing completion. We are now able to offer 50 amp electrical service, sewer & water connections, and we have spread gravel over the entire Club grounds.

The shooter space rates are as follow:

Daily: \$20.00

Weekly: \$110.00

Monthly: \$325.00

In addition to the monthly fees there will be a "practice target requirement" of \$100.00 per month which can be used for 20 rounds of trap or skeet practice. We will be open for shooting 5 days per week from Nov. 1 to April 1. Your targets will need to be prepaid monthly and can be shot at your leisure. All prepaid rounds will expire on July 1st of each year and cannot be transferred nor accumulated.

All space occupants must be members of the Tucson Trap & Skeet Club while occupying a RV space. The following memberships are available: weekly, quarterly, semi-annul, annual, and lifetime.

Please note: All RVs connected to the sewer system must use a secure, odor-tight 4" connection to prevent spills and leaks. Also, should you only require 30 amps electrical, you'll need to provide a 50 amp to 30 amp adaptor cord with a fuse/circuit breaker (per Pima County Code).

We plan to offer a concrete pad option as follows:

Each space will be twenty feet by forty feet. In order to control erosion as well as minimize costs, pads will be poured 4 to a section, based on our existing layout of A, B, C, and D. The purchase of a pad entitles purchaser 2 weeks free usage annually on a reserved basis. TT&SC will have the right to make this space available when not reserved/used by the purchaser. Spaces cannot be transferred nor assigned to others. The normal rates will apply to additional days. The cost per space is \$5,000 based upon a ten year agreement.

The goal of the TT&SC is to accommodate our long time guests and shooters. We will make every effort to locate you according to your preference. Obviously those members reserving spaces on a long term basis will have priority regarding retaining their space during our major shoots. However, the purchaser of a permanent concrete pad will be allowed to select their 2 weeks usage on a priority basis.

Our goal is to have the pad improvements in for this seasons' visitors. We need your response as to your intention by **July 20, 2009**. If you can remit payment with your order it would be appreciated. If you wish to make alternate payment arrangements including credit card purchase, please contact us. **The payment cutoff date for pads that will be available this season is August 15, 2009.** All four pads A, B, C, D must be paid for before construction can begin.

RV locations will be assigned on a first come, first serve basis. With this in mind, it would be wise to contact us ASAP if you wish to retain your current camping location.
